- 2. All transactions are under the <u>Dutch Forwarding</u> and <u>Warehousing conditions</u> which are available at <u>www.metaaltransport.nl/conditions</u>.
- 3.1 Customers must pay the full amount of FOT charges and LME Rent for cancelled warrants.
- 3.2 LME Rent will continue up to and including the date of material collection from LME warehouse.
- 4. Drivers must sign the collection note.
- 5. Drivers need to have strapping belts and anti-slipping mats for lasing and securing of materials. Metaal Transport reserves the right to not load materials in case of insufficient strapping and anti-slipping materials.

# **NOTICE OF DELIVERY OUT PROCEDURES**

#### **Delivery procedures of LME cancelled lots**

- For delivery to Free on Truck (FOT), Free in Container, Free in Barge, Free on Rail, bookings need to be agreed prior loading. Time-/loading slots will be agreed in the booking process.

In addition to any specifically requested information, Metaal Transport B.V. must receive by latest 11:00 am of the working day prior the collection day (loading slots) with the following information:

### Free on Truck/ Free in Container:

- 1. Transport company
- 2. Truck/trailer plate number
- 3. Driver's full name
- 4. Driver id

#### Free in Barge:

- 1. Barge
- 2. Barge crewmembers
- 3. Metaal Transport B.V. must receive the vessel/barge nomination for acceptance by latest 5 (five) working days prior to proposed laycan. The nominated agent must give notice to Metaal Transport B.V. and update E.T.A. of the vessel/barge 72/48/24 hours before arrival for berthing.

#### Free on Rail:

- 1. Railway company
- 2. Waggon numbers + specifications/payloads
- 3. Loading instructions
- 4. Securing instructions (if applicable)
